Partnership  
eligibility

When is a partnership eligible?

See page 11 in the DGBP guidelines for mandatory requirements and exclusion list

A partnership needs to consist of:

- One non-commercial, administrative partner
- One international commercial partner
- One local partner

It is the administrative partner that must submit the final signed application.

The local partner can be both non-commercial and commercial partner

Are partners allowed to submit more than one application?

The various partners in a partnership are allowed to submit more than one application. But the secretariat recommend that you focus your efforts and consider the capacity needed to implement projects.

Can a project be implemented in two countries?

A project can in theory be implemented in two countries, but during the assessment process cost-efficiency is crucial. Therefore it need to be argued extensively what the added value of implementing the project in several countries is. The secretariat do not recommend implementing in two countries.



Funds  
available

How much funding can a partnership apply for?

Partnership projects can apply for:

- DKK 4 - 15 million for a full project
- DKK 1 - 1.5 million for a maturation project.

25% of the budget is required to originate from the commercial partner(s) as own contribution - in cash or in kind.

DMDP  
extension

Can the project be an extension of a DMDP project?

No, a DGBP project cannot be a direct extension of a DMDP project and all applications are assessed based on the same criteria. If a partnership can argue and demonstrate increased additionality and added value in form of new value chains, additional sectors or stakeholders etc. the project will be assessed. Important to note that commercial partners can only be supported for a maximum of 5 years.



Project type

What kind of projects are eligible for funding?

Partnerships can apply for two kinds of projects:

- Full projects
- Maturation projects

It is a requirement that all projects address **green transition**.

It is possible and desirable that maturation project eventually turn into full projects. Note that this is not granted, and that a maturation project needs to submit a full project application along with all other applicants.

Can consultancy firms and multilateral organisations be part of the project?

Yes, both consultancy firms and multilateral organisations can be part of the project.

Multilateral organisations can, however, not be administrative partner and the project has to revolve around an on-the-ground business case hence making the business of consultancy as such in-eligible for funding.

Equipment

The DGBP can financially support test- and demonstration equipment, how is this defined?

There are no definitions for this, including min. / max amounts. It is important that the applicant can validate that the equipment is for demonstration purposes only and have a model in place that defines how the ownerships structure of the equipment will transition to the stakeholders/commercial entities involved in the project.
